Subject: Semi-Annual Impact Fee Collections Report for April 1, 2023 to September 30, 2023

The Semi-Annual Impact Fee Collections Report as of September 30, 2023, is attached for your reference. The report is based on financial information reported in the City's accounting system, ADV3, and in AMANDA, one of the City's accounts receivable systems. Water fees collected during this six-month reporting period were \$4,876,076 lower than the amount collected during the April through September reporting period a year prior; wastewater fees collected were \$2,224,149 lower than those collected during the same period one year ago. Interest earnings for the six-month period equaled \$618,860.

The combined utility impact fees collected, plus interest, during the six-month period totaled \$15,906,125. Of this total, \$10,826,393 was for water and \$5,079,732 was for wastewater. The combined utility impact fees collected, plus interest, during Fiscal Year 2023 totaled \$30,662,889. Of this total, \$21,284,888 was for water and \$9,378,001 was for wastewater. Total combined utility impact fees collected, plus interest, since the adoption of the current ordinance on June 20, 1990, through September 30, 2023, equal \$478,168,880. Of this total, \$323,659,817 was collected for water and \$154,509,063 was collected for wastewater.

As of September 30, 2023, the cash balances in the water and wastewater impact fee funds were \$23,021,414 and \$16,783,603 respectively, for a combined total of \$39,805,017.

Attachment: Semi-Annual Impact Fee Collections Report

Texas Local Government Code, Chapter 395, Section 395.058, requires that the Impact Fee Advisory Committee "file semiannual reports with respect to the progress of the capital improvements plan and report to the political subdivision any perceived inequities in implementing the plan or imposing the impact fee." This report supports the committee by providing financial information about the collection of impact fees, and the value of fee waivers and exemptions. Waivers are granted for policy reasons or are negotiated by City Council; exemptions are allowed under legal code or statute. In this report waivers and exemptions are grouped into one "waivers/exemptions" category. Adjustments are also made in situations in which fees are not owed. Since adjustments are not comparable to waivers/exemptions and do not affect the reporting of fee collection data, adjustments are not included in this report. Impact fees are collected, waived/exempted, and adjusted by both Water and Wastewater.

- Pages 1 and 2 (Charts 1 through 3) detail the impact fees collected by the Combined utility, Water, and Wastewater, detailing fee collection and interest earnings by fiscal year.
- Page 3 (Charts 4 and 5) details the total amount waived/exempted by the Water utility, and the value of waivers/exemptions by category. These charts report data on a semiannual basis, with reporting periods spanning April 1 through September 30.
- Page 4 (Charts 6 and 7) is similar to Charts 4 and 5 but report the information regarding waivers/exemptions granted by the Wastewater utility.
- Page 5 (Charts 8 and 9) report Capital Recovery Fee Collections by month for the current and prior fiscal year for Water and Wastewater.
- Page 6 (Chart 10) Fee Waivers by month and by type for the current fiscal year.
- Page 7 (Chart 11) Affordable Housing Waivers by Development with units by fiscal year
- Page 8: Impact Fee Collections Summary inception to date with current six-month period.

Chart 2: Water Impact Fee Collections and Waivers






Chart 3: Wastewater Impact Fee Collections and Waivers






Chart 4: Water Impact Fees and Waivers/Exemptions




Chart 5: Water Impact Fee Waivers/Exemptions by Type






Chart 6: Wastewater Impact Fees and Waivers/Exemptions





Chart 7: Wastewater Impact Fee Waivers/Exemptions by Type







**Chart 8: Water CRF Collections by Month** 




**Chart 9: Wastewater CRF Collections by Month**

#### Definitions:

- Affordable Housing: May not exempt more than 1,500 service units of affordable housing constructed each fiscal year from the requirement to pay impact fees. Service units of affordable housing within the development known as Robert Mueller Municipal Airport development.
- \*Year-to-date, the total service units waived is 335. These units are primarily located in El Prado at Estancia, Goodnight Ranch and Mueller developments
- Annexation: Water and Wastewater impact fee may not be collected on a water connection that is annexed for full purposes by the City.
- Council Developer Agreements: This is for Council agreements/ordinances specifying the waiver of impact fees.
- Government: Includes a) school waivers not required to pay impact fees imposed under this chapter. Senate Bill 883; b) State of Texas connections for a state owned building or property that is entirely occupied by a state agency c) community gardens that are city supported may not be assessed an impact fee.
- Other: Includes a)Fire protection may not be collected for a connection that is used to provide capacity only;
   b) Duplex 13-3A-10 (F)
