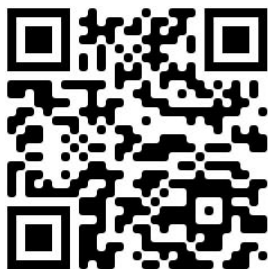
### **Speaker Donation of Time**
