October 18, 2007 - Council approved Ordinance No. 20071018-008 electing to participate in the Texas Enterprise Zone Program.

November 14, 2019 - Council approved Ordinance No. 20191114-068 amending its program identifying additional local incentives for the Texas Enterprise Zone Program.

(NXP), located at 3949 Ed Bluestein Boulevard (ATMC), for designation by the Governor's Office of Economic Development and Tourism as a single Texas Enterprise Project in accordance with Texas Government Code Chapter 2303. The Company included the Council Resolution as a part of its Texas Enterprise Zone Application to the Office of the Texas Governor for consideration in the December 1, 2023, application round. Staff subsequently discovered attestations in the Resolution that are in error. Specifically, the Resolution mistakenly expresses the business site was "within the City's jurisdiction located inside an enterprise zone" and "at least 25 percent of NXP's new permanent jobs will be held by residents of an enterprise zone, economically disadvantaged individuals, or veterans" (Economically Disadvantaged). The amended resolution specifies that the ATMC Location is outside of a designated Enterprise Zone, and that 35 percent of the company's new permanent jobs must be held by Economically Disadvantaged individuals.
