Prior Council Action:

April 11, 2019 - Ordinance No. 20190411-033 amending the Imagine Austin Comprehensive Plan (Ordinance No. 20120614-058) by adopting the Austin Strategic Mobility Plan (ASMP), and including the Bicycle Master Plan, Urban Trails Master Plan, and Sidewalks Master Plan/ADA Transition Plan as part of the ASMP was approved on an 11-0 vote.

June 9, 2022 - Ordinance No. 20220609-052 amending the Austin Strategic Mobility Plan (Ordinance No. 20190411-033) and amending the Imagine Austin Comprehensive Plan was approved on a 10-0 vote with Council Member Renteria abstaining.

November 9, 2023 - Resolution No. 20231109-029 initiating amendments to the Climate Equity Plan and to elements of the Imagine Austin Comprehensive Plan, including the Austin Strategic Mobility Plan, regarding telework policies was approved on a 9-1 vote with Council Member Kelly voting nay and Council Member Harper-Madison absent.

November 30, 2023 - Ordinance No. 20231130-084 amending the Austin Strategic Mobility Plan (Ordinance No. 20190411-033); replacing the Bicycle Master Plan, and Urban Trails Master Plan; renaming and replacing the Sidewalk Master Plan/ADA Transition Plan; and amending the Imagine Austin Comprehensive Plan was approved on 10-0 vote with Council Member Ryan Alter absent.

Mobility Plan, as recommended by the Planning Commission. The Planning Commission amendments make two changes to existing Indicators & Targets and Action Items in the ASMP regarding teleworking for City of Austin employees. If approved, this item will set a public hearing so that the Council can consider adopting the amendments initiated in November.

The Resolution also requested changes to the City's Climate Equity Plan, which is managed by the Office of Sustainability. The changes specific to the Climate Equity Plan will come as a separate agenda item. City staff anticipate bringing those changes to the February 15, 2024, Council meeting.
