Public Improvement Bonds – Balance by Category



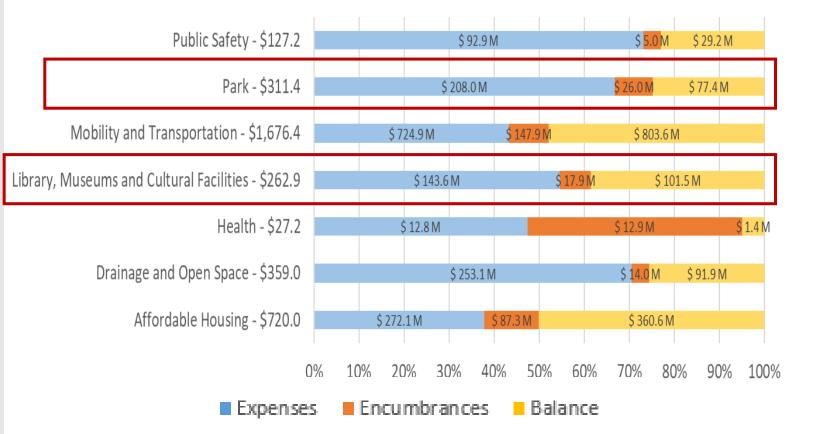
The Parks **Bond Program** from **2006 to 2018 is \$311.4M;** the LM&CC **Bond Program** for **2018 is \$66.5M**

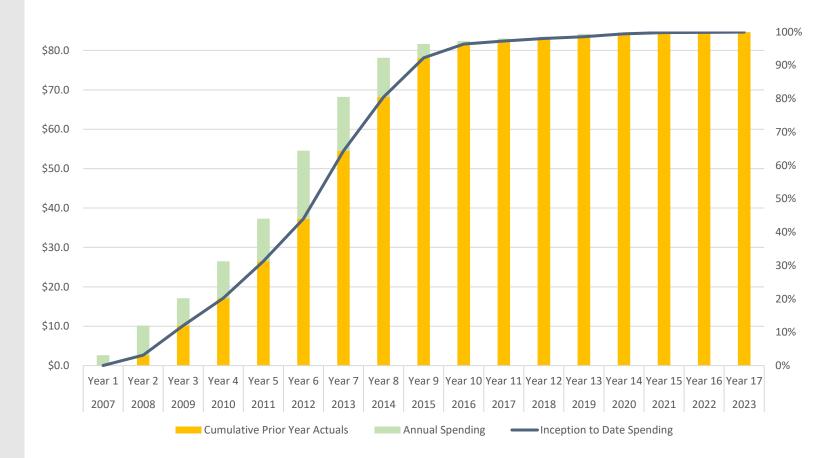

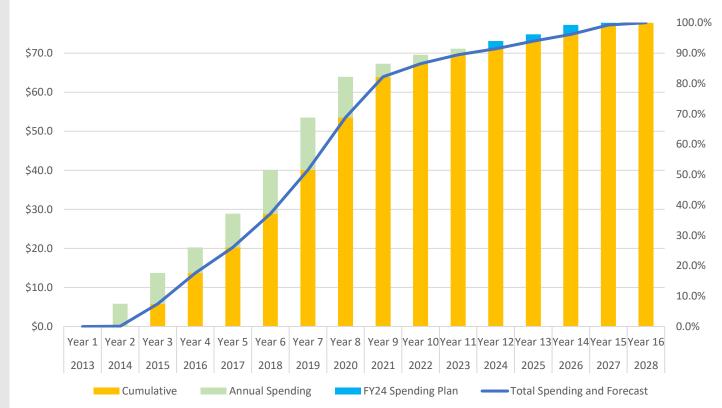
