# AN ORDINANCE APPOINTING TWO INDIVIDUALS TO FILL VACANCIES AND TO SERVE FULL TERMS ON THE MUNICIPAL CIVIL SERVICE COMMISSION, APPOINTING A CHAIR, AND WAIVING CITY CODE SECTION 2-1-21(H) REGARDING SERVICE ON MORE THAN ONE BOARD.

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

## PART 1. Findings

(A) Article IX, Section 2(B) of the City Charter provides for the appointment of commissioners to the Municipal Civil Service Commission (MCSC) by Council.

(**B**) Article IX, Section 2(B) of the City Charter provides for Council to fill any vacancy on the MCSC by appointment for the remainder of the term.

(C) Two vacancies exist on the MCSC both with terms expiring May 8, 2024, and the Council Audit and Finance Committee has nominated two individuals to fill the vacancies on the Municipal Civil Service Commission.

**(D)** The Council Audit and Finance Committee has nominated the same two individuals to be commissioners of the MCSC for specified full terms.

(E) Article IX, Section 2(B) of the City Charter provides for the designation by the Council of one of the commissioners of the MCSC as chair.

(F) The individual currently serving as chair is resigning as chair, creating a vacancy in the chair position.

(G) One of the nominated individuals serves on another commission and must be granted a waiver to serve on the MCSC.

**PART 2.** Council appoints the following individuals as commissioners of the MCSC, to serve the remainder of the term of the vacated positions, expiring on May 8, 2024:

- Mapi Vigil
- Melissa Rogers

**PART 3.** Council appoints the following individuals as commissioners of the MCSC, to serve a three-year term that expires on May 8, 2027:

**PART 4.** Council designates Kevin Mullen as chair of the MCSC to a term expiring May 8, 2025.

**PART 5.** Council approves a waiver of the requirement in Section 2-1-21(H) of the City Code for the appointment of Melissa Rogers, thereby allowing her simultaneous service on the Municipal Civil Service Commission and City of Austin Firefighters ' Police Officers' and Emergency Medical Services Personnel Civil Service Commission.
