#### Abstract

AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 518 NORTH PLEASANT VALLEY ROAD AND 507 CALLES STREET IN THE HOLLY NEIGHBORHOOD PLAN AREA FROM LIMITED INDUSTRIAL SERVICE-CONDITIONAL OVERLAYNEIGHBORHOOD PLAN (LI-CO-NP) COMBINING DISTRICT TO GENERAL COMMERCIAL SERVICES-MIXED USE-VERTICAL MIXED USE BUILDINGCONDITIONAL OVERLAY-NEIGHBORHOOD PLAN (CS-MU-V-CO-NP) COMBINING DISTRICT.


## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from limited industrial service-conditional overlay-neighborhood plan (LI-CO-NP) combining district to general commercial services-mixed use-vertical mixed use building-conditional overlay-neighborhood plan (CS-MU-V-CO-NP) combining district on the property described in Zoning Case No. C14-2023-0111, on file at the Planning Department, as follows:

A 3.810 acre tract of land, being the remainder of a called 3.888 acre tract out of Outlots 12 and 21, Division A, in the City of Austin, Travis County, Texas, conveyed by deed recorded in Document No. 2019164566 of the Official Public Records of Travis County, Texas, said 3.810 acre tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance (the "Property"),
locally known as 518 North Pleasant Valley Road and 507 Calles Street in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit "B".

PART 2. The Property within the boundaries of the conditional overlay combining district established by this ordinance is subject to the following conditions:
(A) The following uses are prohibited uses of the Property:

| Adult-oriented businesses | Campground |
| :--- | :--- |
| Convenience storage | Exterminating services |
| Kennels | Pawn shop services |

(B) The following uses are conditional uses of the Property:

Automotive washing (of any type) Commercial off-street parking
PART 3. Except as specifically restricted under this ordinance, the Property may be developed and used in accordance with the regulations established for the general commercial services (CS) base district, the mixed use combining district, and other applicable requirements of the City Code.

PART 4. Except as specifically modified by this ordinance, the Property is subject to Ordinance No. 011213-44 that established zoning for the Holly Neighborhood Plan.

PART 5. This ordinance takes effect on February 12, 2024.

## LEGAL DESCRIPTION


#### Abstract
