

M/WBE Summary

Public notice was given for this solicitation (CLMC1012, 38th and 40th Streets Water and Wastewater Pipeline Renewal), through the City's Financial Services website, Austin Finance Online. Four bids were received and opened on December 7, 2023. Of the four bids received, two bids were from an MBE/WBE certified firm. Cedar Hills Construction, LLC, submitted the lowest responsive bid including an alternate bid item of \$588,255 and allowances in the amount of \$500,000:
