1 AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE
2 PROPERTY LOCATED AT 4201 SOUTH CONGRESS AVENUE IN THE SOUTH
3 CONGRESS COMBINED NEIGHBORHOOD PLAN AREA FROM LIMITED
4 INDUSTRIAL SERVICE-NEIGHBORHOOD PLAN (LI-NP) COMBINING
5 DISTRICT AND LIMITED INDUSTRIAL SERVICE-CONDITIONAL OVERLAY-
6 NEIGHBORHOOD PLAN (LI-CO-NP) COMBINING DISTRICT TO GENERAL
7 COMMERCIAL SERVICES-MIXED USE-VERTICAL MIXED USE BUILDING-
8 CONDITIONAL OVERLAY-NEIGHBORHOOD PLAN (CS-MU-V-CO-NP)
9 COMBINING DISTRICT.

11 BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:
12

13 **PART 1.** The zoning map established by Section 25-2-191 of the City Code is amended to
14 change the base district from limited industrial service-neighborhood plan (LI-NP)
15 combining district and limited industrial service-conditional overlay-neighborhood plan
16 (LI-CO-NP) combining district to general commercial services-mixed use-vertical mixed
17 use building-conditional overlay-neighborhood plan (CS-MU-V-CO-NP) combining
18 district on the property described in Zoning Case No. C14-2023-0043, on file at the
19 Planning Department, as follows:
20

21 A 5.515 acre tract of land out of the ISSAC DECKER LEAGUE, ABSTRACT
22 NO. 8, in Travis County, Texas, being all of a called 5.515 acre tract of land
23 conveyed in document recorded in Volume 13128, Page 248, of the Real Property
24 Records of Travis County, Texas, said 5.515 acre tract of land being more
25 particularly described by metes and bounds in **Exhibit “A”** incorporated into this
26 ordinance (the “Property”),
27

28 locally known as 4201 South Congress Avenue in the City of Austin, Travis County,
29 Texas, generally identified in the map attached as **Exhibit “B”**.

31 **PART 2.** The Property within the boundaries of the conditional overlay combining district
32 established by this ordinance is subject to the following conditions:

37 **PART 3.** Except as specifically restricted under this ordinance, the Property may be
38 developed and used in accordance with the regulations established for the general
39 commercial services (CS) base district, the mixed use combining district, and other
40 applicable requirements of the City Code.

42 **PART 4.** Except as specifically modified by this ordinance, the Property is subject to
43 Ordinance No. 20050818-Z004 that established zoning for the East Congress
44 Neighborhood Plan.

THENCE, with the north right-of-way line of said Industrial Boulevard and the south line of said 5.515 acre tract, the following two (2) courses and distances:

- 1) **N62°42’28”W**, a distance of **103.81** feet to a 1/2-inch iron rod found for an angle point hereof, and
- 2) **N62°29’04”W**, a distance of **600.39** feet to Mag nail with “4Ward Boundary” washer set for the southwest corner hereof, said point being in the east right-of-way line of South Congress Avenue (right-of-way varies), and being the southwest corner of said 5.515 acre tract;

THENCE, leaving the north right-of-way line of said Industrial Boulevard, with the east right-of-way line of said South Congress Avenue and the west line of said 5.515 acre tract, **N27°22’30”E**, a distance of **341.10** feet to an “X” cut in concrete found for the northwest corner hereof, said point being in the south right-of-way line of International-Great Northern Railroad (also known as Bergstrom Field Spur, 50’ right-of-way, this portion of right-of-way being apparently abandoned), also being the northwest corner of said 5.515 acre tract;

THENCE, with the south right-of-way line of said I.G.&N. THENCE, leaving the south right-of-way line of said I.G.&N. Railroad, with the common line of said 5.515 acre tract and said 0.843 acre tract, **S27°00'39"W**, a distance of **341.98** feet to the **POINT OF BEGINNING** and containing 5.5156 Acres (240,259 Square Feet) more or less.


