# HISTORIC LANDMARK COMMISSION DEMOLITION AND RELOCATION PERMITS MARCH 6, 2024 DA-2024-001855; GF-2024-018655 503 WALSH STREET

### **PROPOSAL**

Demolish a ca. 1894 house.

### ARCHITECTURE

One-and-a-half-story cross-gabled house with partial width porch, traditional cornice returns at gable ends, 2:2 wood windows, and stucco cladding.

### RESEARCH

The house at 503 Walsh Street, originally addressed as 503 Blanco Street, was constructed around 1894. Its first residents were Frank and Emma Casper and their daughter, Byrdie. Dr. Frank Casper worked as a dentist, with office space on Congress Avenue and Colorado Street. Frank Casper claimed to be the heir to Abel Casper, whose Mississippi plantation was requisitioned by the Union Army during the Civil War; Dr. Casper attempted to solicit restitution money from the federal government forty years later, though it did not appear that he was successful.

After Casper's death around 1916, the house passed to his widow, Emma. Its primary tenants were James A. Warren and his family. James Warren was the bookkeeper and cashier for the City's Street and Public Improvement division, and served a brief stint as City Clerk.

During the 1920s, the house became a rental property, home to several short-term occupants. Occupants during the thirties, forties, and fifties included a widow, an engineer, and City Electric Department employees.


### PROPERTY EVALUATION


Designation Criteria—Historic Landmark

- 1) The building is more than 50 years old.
- 2) The building appears to retain moderate integrity. Gables have been altered and the building has been clad in stucco, though modifications may have taken place during the historic period.
- 3) Properties must meet two criteria for landmark designation (LDC §25-2-352). Staff has evaluated the property and determined that it does not meet two criteria for landmark designation:
  - a. Architecture. The building is constructed with Folk Victorian influences, but character-defining features have been removed or altered over the years.
  - b. Historical association. The property does not appear to have significant historical associations.
  - c. Archaeology. The property was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
  - d. Community value. The property does not appear to possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
  - e. Landscape feature. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

### STAFF RECOMMENDATION

Encourage rehabilitation and adaptive reuse but release the demolition permit upon completion of a City of Austin Documentation Package.



## DR. F. S. CASPER HAS A CASE FOR DAMAGES

Grant's Army Took That Which Belonged to His Father in Mississippi During the Civil War.

United States Commissioner J. R. Little heard depositions yesterday in a most interesting tase which dates back to the civil war.

This case is now pending before the United States courts of claims at Washington. United States District Attorney Henry Terrell was here representing the government, while Major W. M. Walton represents Mr. Casper.

Abel Casper was one of the wealthiest citizens of Mississippi in the early
60's, and when Grant's army invaded
Jackson, Miss., they appropriated, according to the allegations of the plaintiff, molasses, shoes, whisky and provisions of all kinds to their own use
which belonged to the elder Casper.
This was on May 14, 1863, and after
the war came to an end the matter was
taken up by Dr. Caspar and the claim
is still pending. The case involves
many thousands of dollars and may yet
take sometime before it is finally adjusted.

Both of the district courts adjourned yesterday for the term. It was after 10 o'clock last night when the Fifty-third district court completed its business, while the Twenty-sixth district court finished earlier in the evening.

## Warren Will Remain Clerk A Week More

J. A. Warren, who is city clerk, will be retained in that capacity for about a week longer, but will go back to his old duties of chief clerk and paymaster of the street department. V. E. Martin will be the nominal city clerk. This was decided upon following the suggestion of Judge T. S. Johnson, special assistant city attorney in charge of the school bonds.

According to Judge Johnson, the William R. Compton Company, St. Louis, bond brokers, who are selling the school bonds, have a rule against selling bonds after the Mayor who signed the bonds had relinquished his office. The attorney feared the same rule might apply in regard to the city clerk who attested the bonds. He suggested that Warren go back to the street department but continue the city's legal city clerk until the bonds are disposed of, which city officials declare will take about a week. Martin, however, was to continue as nominal city clerk until the bond affair is closed and the city has the money. This will take a week, said the Mayor.

The commissioners voted \$1460 as commission and brokerage to the bond company for the disposal of the bonds. The Mayor already has received a voucher from the school board reimbursing the city government for this outley.

Upon the nomination of Commissioner Haynes, Ed R. Huck and R. H. Felter were named special assistant assessors to aid Fred Sterzing, the tax collector, with the assessments that soon will be made.

## Council's Advice In Collecting Bills For Streets Asked

A request for instructions on further courses of action against residents of Austin who offered to pay for street improvements if the city would do the work, but later refused to make the payments was filed with the city council by J. A. Warren, cashier of the street department, in a report made Thursday.

Mr. Warren cited specific examples of residents on East 12th street who had refused to pay bills rendered by the city after they had agreed to pay for street improvements, and said that they offered as a defense that East 11th street had been similarly improved without cost to the property owners. Mr. Warren also reported that former Commissioner George P. Searight had instructed him to bill the East 11th street residents, and that many who had received the bills had refused to pay on the grounds that the work was done without their knowledge or consent.

The report also stated that the city attorney had filed suit against some of the signers of the offer to pay for the East 12th street improvements, but that no results had been obtained so far.

Mr. Warren also criticized the maintenance of a special street fund, which had a 6 cent balance on June 30, 1926. Into this fund all monies collected for the improvement of specific streets are placed. The fund is "unsatisfactory for the reason that some streets are improved and charged to property owners while others receive a similar improvement at the city's expense," the report says.

The report was referred to the city manager for action.
