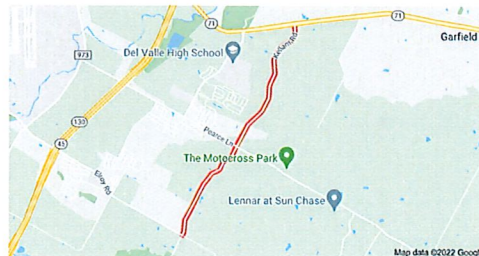
Re: Kellam Road Name Change – COTA Blvd

To Whom It May Concern,

This letter is sent as a request to change the name of Kellam Rd to COTA Blvd. Kellam Rd is a relatively new thoroughfare that has minimal residents or businesses. Kellam was built partially to allow traffic to reach Circuit of The Americas from HWY-71 and transitions into Circuit of The Americas Blvd at the Elroy Rd intersection. Giving the same name throughout the entire thoroughfare will cause less confusion by allowing more people to take a direct path to their destination. Traffic engineers and advisors have recommended this change and suggest that a single consistent name will alleviate some of the stray neighborhood traffic.

COTA believes this request will support both community-based traffic patterns, as well as event-based traffic patterns when traveling throughout the Del Valley and City of Austin community.

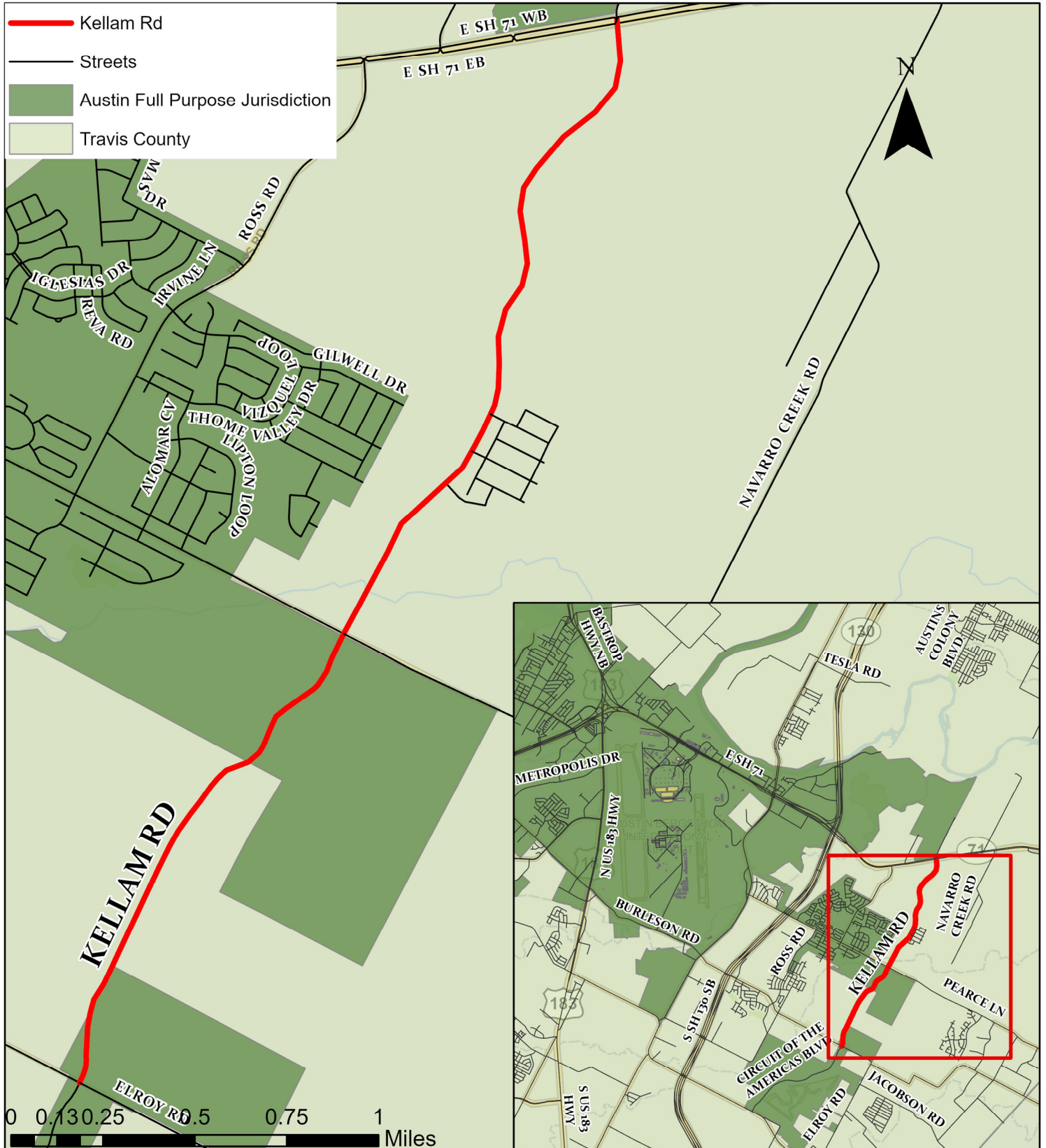
