Public notice was given for this solicitation, CLMC1017 for the Harold Court Service Center WPD Campus Improvements project, through the City's Financial Services website, Austin Finance Online. Three bids were received and opened on December 14, 2023. Of the three bids received none of the firms submitting were certified MBE/WBE. Jerdon Enterprise, L.P. submitted the lowest responsive bid:
