### **Posting Language**

Authorize execution of three contracts for dry rock rip rap crushed aggregate with Schuler Contracting LLC; Green Dream International; and Dalrymple Gravel and Contracting, each for a term of five years for total contract amounts not to exceed \$6,898,113, divided among the contractors.

[Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9B (Minority-Owned and Women-Owned Business Enterprise Procurement Program). For the goods required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established].

Financial Services Department.

All City Departments.

### **Fiscal Note**

Funding in the amount of \$486,111 is available in the Fiscal Year 2023-2024 Operating Budget of various City departments for these goods.

Funding for the remaining contract term is contingent upon available funding in future budgets.

### **Purchasing Language:**

The Financial Services Department issued an Invitation for Bids (IFB) 5000 TJP1001 for these goods. The solicitation was issued on January 1, 2024, and closed on January 22, 2024. Of the five offers received, the recommended contractors submitted the lowest and most responsive offers. ### **Additional Backup Information:**

This contract is for limestone and dolomite crushed stone and dry rock rip rap for various City departments. The crushed rock is used for erosion control in concrete pipe infrastructure, for minimizing ice and snow build-up on streets, repair eroded embankments, fill scour holes in creek beds, stabilize channel bottoms for heavy duty equipment, and for emergency bridge and road stabilization during flooding events.

The requested authorization amount is based upon historical spending and annual usage amounts.

This contract will replace the current contract for crushed rock and rip rap which expired January 23, 2024. A delay in contract approval could impact repair projects and repair of infrastructure erosion caused by flood events.
