

**PETITION IN OPPOSITION TO ANY MORE COCKTAIL LOUNGES ON EAST 11<sup>TH</sup> STREET**

**We the undersigned stakeholders in the East 11<sup>th</sup> Street NCCD and Urban Renewal Plan area urge you to make cocktail lounges and liquor sales a Prohibited Use, not only at 1201 East 11<sup>th</sup> Street, TCAD PID 192999 and GID 0205071004000, but in all of Subdistrict One of the East 11<sup>th</sup> Street NCCD where they are not currently permitted.**

In 1986, the East 11<sup>th</sup> Street corridor was zoned CS-1, a permissive zoning classification that allows many commercial uses, including liquor sales, which are not typically located near homes or churches. In 1991, the Neighborhood Conservation Combining District (NCCD) was adopted and, in response to the terrible conditions along E. 11<sup>th</sup> Street, it made cocktail lounges and liquor stores a conditional use. **The 1999 Urban Renewal Plan, in response to broad community input, assigned uses to the tracts along E. 11<sup>th</sup> Street that did not permit cocktail lounges or liquor stores. The Urban Renewal plan was on the right track by prohibiting cocktail lounges. The NCCD should align with the Urban Renewal Plan and prohibit new bars on E. 11<sup>th</sup> Street.**

In 2021, after extensive community input, as part of amending the NCCD, the Urban Renewal Board recommended making cocktail lounges a "Prohibited Use". In similar fashion, the Planning Commission's Working Group recommended cocktail lounges be allowed only as an accessory use to hotel and motel uses in the NCCD's Subdistrict One. These were sound recommendations.

Ebenezer Baptist Church, Ebenezer's Child Development Center, and more than a dozen single-family homes are only 20 feet from where cocktail lounges could be allowed on the south side of E. 11<sup>th</sup> Street. **1201 E. 11<sup>th</sup> Street actually shares a property line with two 4-bedroom family homes.** There is already a cocktail lounge and a liquor store at 1133 East 11<sup>th</sup> Street, across an alley and street from single family homes. Allowing more cocktail lounges on E. 11<sup>th</sup> Street would be contrary to the health, safety and well-being of the community.

The reasons for prohibiting cocktail lounges are compelling:

- Cocktail lounges near single-family homes and churches are contrary to the intent of a NCCD which is "to preserve and protect older residential neighborhoods" and "to enhance the desirability of living in older neighborhoods."
- It is contrary to the Urban Renewal Plan, as adopted in 1999, which has uses that do not permit liquor sales or a cocktail lounge at 1201 E. 11<sup>th</sup> Street or elsewhere on E. 11<sup>th</sup> Street.
- Cocktail Lounges on the south side of E. 11<sup>th</sup> Street will be detrimental to the health, safety and well-being of families and the surrounding community and should be prohibited.

**We the undersigned urge you to make cocktail lounges and liquor sales a Prohibited Use, not only at 1201 E. 11<sup>th</sup> Street, TCAD PID 192999, GID 0205071004000, but in all of Subdistrict One of the East 11<sup>th</sup> Street NCCD where it is not currently permitted.**

**Nosotros, los abajo firmantes en el área de East 11th Street NCCD y el Plan de Renovación Urbana le instamos a que haga de los bares tipo de lounge de cócteles, bares y las ventas de licor un Uso Prohibido, no solo en 1201 East 11th Street, TCAD PID 192999 y GID 0205071004000, sino en todo el Subdistrito Uno de East 11th Street NCCD, donde actualmente no están permitidos.**

En 1986, el corredor de East 11th Street fue zonificado CS-1, una clasificación de zonificación permisiva que permite muchos usos comerciales, incluida la venta de licor, que generalmente no se encuentran cerca de casas o iglesias. En 1991, se adoptó el Distrito Combinado de Conservación del Vecindario (NCCD) y, en respuesta a las terribles condiciones a lo largo de la calle E. 11, hizo que los salones de cócteles y las licorerías fueran de uso condicional. **El Plan de Renovación Urbana de 1999, en respuesta a la amplia participación de la comunidad, asignó usos a los tramos a lo largo de la calle E. 11 que no permitían salones de cócteles o licorerías. El plan de Renovación Urbana iba por buen camino al prohibir los salones de cócteles. El NCCD debería alinearse con el Plan de Renovación Urbana y prohibir nuevos bares en E. 11th Street.**

En 2021, después de una amplia participación de la comunidad, como parte de la enmienda del NCCD, la Junta de Renovación Urbana recomendó que los salones de cócteles fueran de "Uso prohibido". De manera similar, el Grupo de Trabajo de la Comisión de Planificación recomendó que los salones de cócteles se permitieran sólo como un uso accesorio para los usos de hoteles y moteles en el Subdistrito Uno del NCCD. Fueron recomendaciones acertadas.

La Iglesia Bautista Ebenezer, el Centro de Desarrollo Infantil de Ebenezer y más de una docena de casas unifamiliares están a solo 20 pies de donde se podrían permitir salones de cócteles en el lado sur de E. 11th Street. **1201 E. 11th Street en realidad comparte una línea de propiedad con dos casas familiares de 4 dormitorios.** Ya hay un salón de cócteles y una licorería en 1133 East 11th Street, al otro lado de un callejón y una calle de casas unifamiliares. Permitir más salones de cócteles en E. 11th Street sería contrario a la salud, la seguridad y el bienestar de la comunidad.

Las razones para prohibir los salones de cócteles son convincentes:

- Los salones de cócteles cerca de casas unifamiliares e iglesias son contrarios a la intención de un NCCD, que es "preservar y proteger los vecindarios residenciales más antiguos" y "mejorar la conveniencia de vivir en vecindarios más antiguos".
- Es contrario al Plan de Renovación Urbana, tal como se adoptó en 1999, que tiene usos que no permiten la venta de licores o un salón de cócteles en 1201 E. 11th Street o en cualquier otro lugar de E. 11th Street.
- Los salones de cócteles en el lado sur de E. 11th Street serán perjudiciales para la salud, la seguridad y el bienestar de las familias y la comunidad circundante y deben estar prohibidos.



























